

BINARY CODE LICENSE TERMS AND CONDITIONS OF EBSOTECH

1. LICENSE TO USE.

Ebsotech Oy. ("Ebsotech") grants the customer ("CUSTOMER") a non-exclusive and non-transferable license for the internal use only of the accompanying software, documentation and any error corrections provided by Ebsotech (collectively "Software"), by the number of computer hardware unit running operating system, for which the corresponding fee has been paid. Subject to the terms and conditions of this Agreement Ebsotech grants CUSTOMER a non-exclusive, non-transferable, limited license to reproduce internally and use internally the binary form of the Software complete and unmodified for the sole purpose of designing, developing and testing your applications intended to run on the Ebsotech platform.

2. RESTRICTIONS

Software is confidential and copyrighted. Title to Software and all associated intellectual property rights is retained by Ebsotech and/or its licensors. Except as specifically authorized in any Supplemental License Terms, you may not make copies of Software, other than a single copy of Software for archival purposes. Unless enforcement is prohibited by applicable law, you may not modify, decompile, or reverse engineer Software. You acknowledge that Software is not designed, licensed or intended for use in the design, construction, operation or maintenance of any nuclear facility. Ebsotech disclaims any express or implied warranty of fitness for such uses. No right, title or interest in or to any trademark, service mark, logo or trade name of Ebsotech or its licensors is granted under this Agreement.

Software may contain source code that is provided solely for reference purposes pursuant to the terms of this Agreement. Source code may not be redistributed unless expressly provided for in this Agreement.

Either party may terminate this Agreement immediately should any Software become, or in either party's opinion be likely to become, the subject of a claim of infringement of any intellectual property right.

3. LIMITED WARRANTY

Ebsotech warrants to CUSTOMER that for a period of ninety (90) days from the date of purchase, as evidenced by a copy of the receipt, the media on which Software is furnished (if any) will be free of defects in materials and workmanship under normal use. Except for the foregoing, Software is provided "AS IS". Your exclusive remedy and Ebsotech's entire liability under this limited warranty will be at Ebsotech's option to replace Software media or refund the fee paid for Software.

4. DISCLAIMER OF WARRANTY

UNLESS SPECIFIED IN THIS AGREEMENT, ALL EXPRESS OR IMPLIED CONDITIONS, REPRESENTATIONS AND WARRANTIES, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT ARE DISCLAIMED, EXCEPT TO THE EXTENT THAT THESE DISCLAIMERS ARE HELD TO BE LEGALLY INVALID.

5. LIMITATION OF LIABILITY

TO THE EXTENT NOT PROHIBITED BY LAW, IN NO EVENT WILL EBSOTECH OR ITS LICENSORS BE LIABLE FOR ANY LOST REVENUE, PROFIT OR DATA, OR FOR SPECIAL, INDIRECT, CONSEQUENTIAL, INCIDENTAL OR PUNITIVE DAMAGES, HOWEVER CAUSED REGARDLESS OF THE THEORY OF LIABILITY, ARISING OUT OF OR RELATED TO THE USE OF OR INABILITY TO USE SOFTWARE, EVEN IF EBSOTECH HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. Any action related to this Agreement will be governed by the law of Finland. No choice of law rules of any jurisdiction will apply.

8. SEVERABILITY

If any provision of this Agreement is held to be unenforceable, this Agreement will remain in effect with the provision omitted, unless omission would frustrate the intent of the parties, in which case this Agreement will immediately terminate.

9. INTEGRATION

This Agreement is the entire agreement between XXX and Ebsotech relating to its subject matter. It supersedes all prior or contemporaneous oral or written communications, proposals, representations and warranties and prevails over any conflicting or additional terms of any quote, order, acknowledgment, or other communication between the parties relating to its subject matter during the term of this Agreement.
